Selection Criteria

Internships in the Office of Congressman David Scott are open to high school seniors, undergraduate or graduate students in good academic standing and recent graduates. All applicants should have a demonstrated interest in public service and excellent research and writing skills.

The Internship Program is designed especially to allow students to apply lessons learned in class to a work environment, to make professional contacts and to obtain extensive knowledge of government agencies and, more specifically, to learn how a Congressional office functions to serve constituents. In today's job market, the experience that an internship provides is vital for career development. The program is non-paid; however, students may earn academic credit.

The selection process is highly competitive. Candidates are selected based on academic achievement, demonstrated leadership, interest in public policy and community service contributions. The staff will initially review each application. Then, promising candidates will be contacted for interviews.

Application Instructions

- 1. Complete <u>all</u> sections of the application, even if a resume is also submitted.
- 2. Submit a letter of recommendation written by either a current or former instructor or current or former employer.
- 3. Submit official transcripts from all institutions attended.
- 4. Submit a one-page essay for <u>one</u> of the following questions (750 words minimum):

- What do you hope to gain as an intern in the Office of Congressman David Scott? Describe how this position ties into your future goals.

- What qualities distinguish you as a leader? Describe a time when you displayed excellent skills as a leader of others.

- As the advisor to a congressional member who represents a diverse constituency, what measures would you recommend to address disparities in education?

BIOGRAPHY OF UNITED STATES REPRESENTATIVE DAVID SCOTT (GA-13)

David Scott is the U.S. Representative for the 13th District of Georgia. He is serving in his fourth term representing portions of 6 counties: Cobb, Clayton, Douglas, Fulton, Henry and DeKalb. Congressman Scott sits on a number of influential committees including:

- The Financial Services Committee Capital Markets and Financial Institutions subcommittees.
- The Foreign Affairs Committee Vice-chair of the Terrorism, Nonproliferation and Trade Subcommittee and member of the Europe Subcommittee.
- The Agriculture Committee Chairman of the Livestock, Dairy and Poultry Subcommittee.
- NATO Parliamentary Assembly Vice-Chair of the Science and Technology Committee.

Congressman Scott is providing leadership in strengthening our economy, improving healthcare, enhancing education and fostering energy independence. He is taking a leadership role on the following issues in Congress:

- Led the fight to pass Children's Health Insurance Protection Act extension (Peachcare)
- Continues the fight to bring commuter rail to the Atlanta suburbs
- Fought to direct more stimulus funding to foreclosure relief
- Authored the law providing student loan repayment assistance for public attorneys
- Authored the law recognizing Fathers Day by flying the flag

GEORGIA LEGISLATURE

Congressman Scott served in the Georgia House of Representatives 1974 - 1982 and the Georgia Senate 1983 - 2002. As a State Senator, he authored the law giving breast cancer patients and their physicians the right to determine their length of stay in the hospital and their level of medical treatment. In addition, he authored the law creating a moment of quiet reflection each morning in public schools. He also authored the law that keeps landfills from being developed in residential neighborhoods.

David Scott was born in Aynor, South Carolina and attended elementary school in Scranton, Pennsylvania, Junior High School in Scarsdale, New York, and High School in Daytona Beach, Florida. He received his BA degree with honors from Florida A&M University. He received his MBA degree with honors from the Wharton School of Finance at the University of Pennsylvania.

He is married to the former Alfredia Aaron and has two daughters, a son-in-law, and two grandchildren. Congressman Scott is the son of a minister and is a man of strong faith and conviction.
