Securing Funding For the USPS

While the USPS has historically funded itself, the COVID-19 pandemic has accelerated their ongoing financial issues. And, I have consistently supported efforts to ensure that the USPS stays well-funded.

While I was pleased to vote for the **CARES Act**, which provided a \$10 billion line of credit for the Postal Service, it was not enough to make up for lost revenue due to the resulting economic downturn. Therefore, I sponsored **H.R. 6425, the Protect Our Post Offices Act**; **H.R. 8015, the Delivering for America Act**; and **H.R. 8406, the HEROES Act**, all of which would provide critical emergency appropriations for the United States Postal Service.

H.R. 8015

DELIVERING FOR AMERICA ACT

- ✉ \$25 billion to support the Postal Service.
- ✉ Prohibits the removal of mailboxes.
- ✉ Prohibits the removal, decommissioning, or other stoppage of mail sorting machines.
- ✉ Requires the Postal Service to treat all official election mail as First-Class mail.
- ✉ Reverses any changes already implemented to the operations or policies of the Postal Service that delay mail delivery.

Congressman David Scott voted to pass **H.R. 8015, the Delivering for America Act** in August to secure essential resources for the United States Postal Service.



TRANSPORTATION

Securing Funding For Roads, Bridges, & Highways

GA-13 includes the fastest growing counties in Georgia. The key to building and maintaining strong infrastructure is to secure funding for projects to improve our current roads, bridges, highways, and public services and to seek new investments that expand access and interconnectivity.

As such, I was proud to cosponsor and vote for **H.R. 2, the Moving Forward Act**, to provide critical funding to help rebuild our roads, bridges, and transit systems.

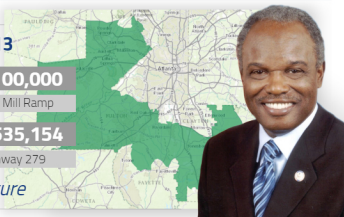

Securing Housing Assistance

I sponsored **H.R. 1988, the Protecting Affordable Mortgages for Veterans Act**, to promote affordability and preserve strong refinancing requirements for veterans.

This bill is a key step forward in ensuring that our nation's beloved veterans can achieve homeownership and pay their monthly payments.

And, I sponsored **H.R. 6729, the COVID-19 Homeowner Assistance Fund Act of 2020**, establishing a \$175 billion fund to help homeowners and renters pay their mortgages, rent, and their water, electricity, and gas utility bills.
